

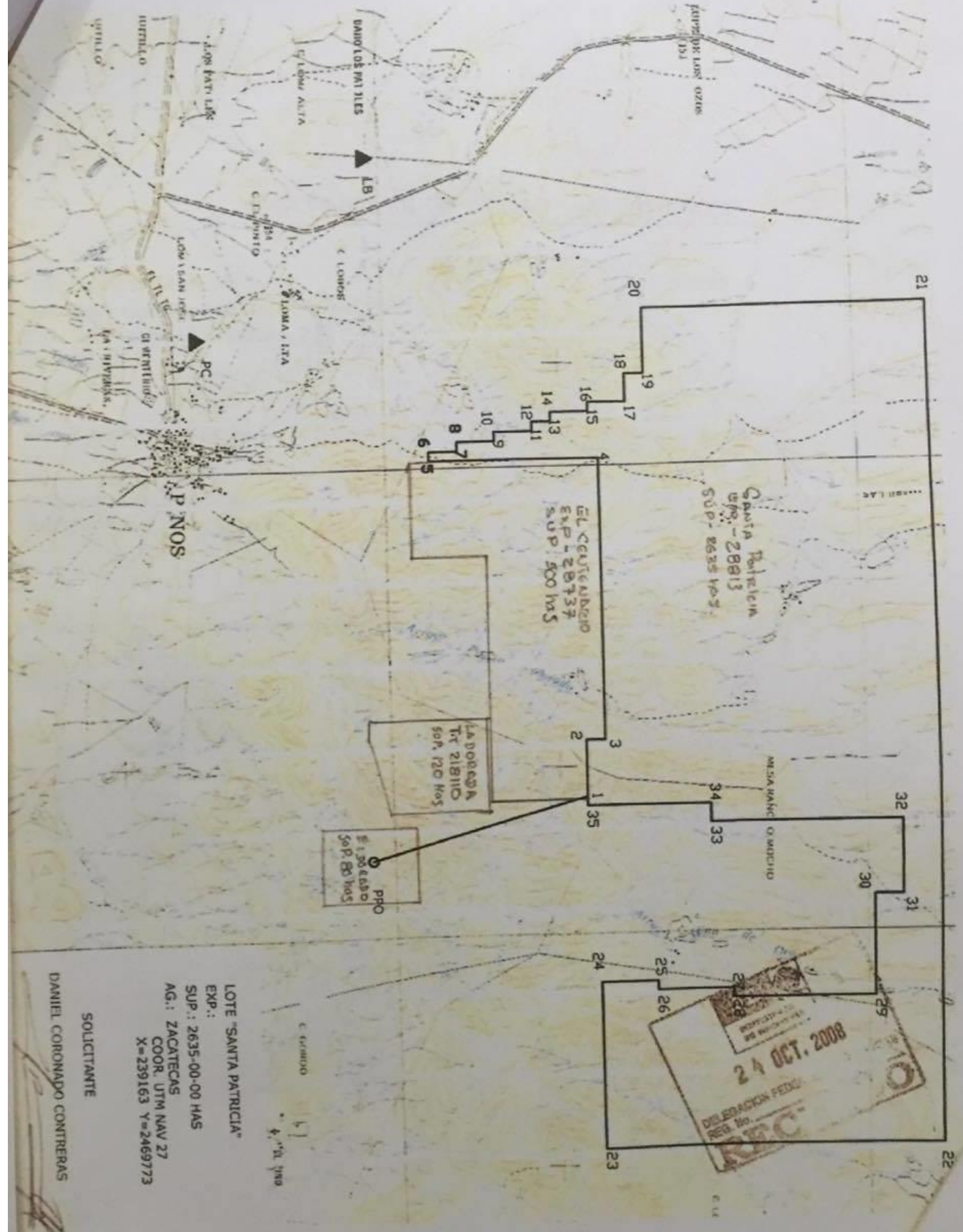

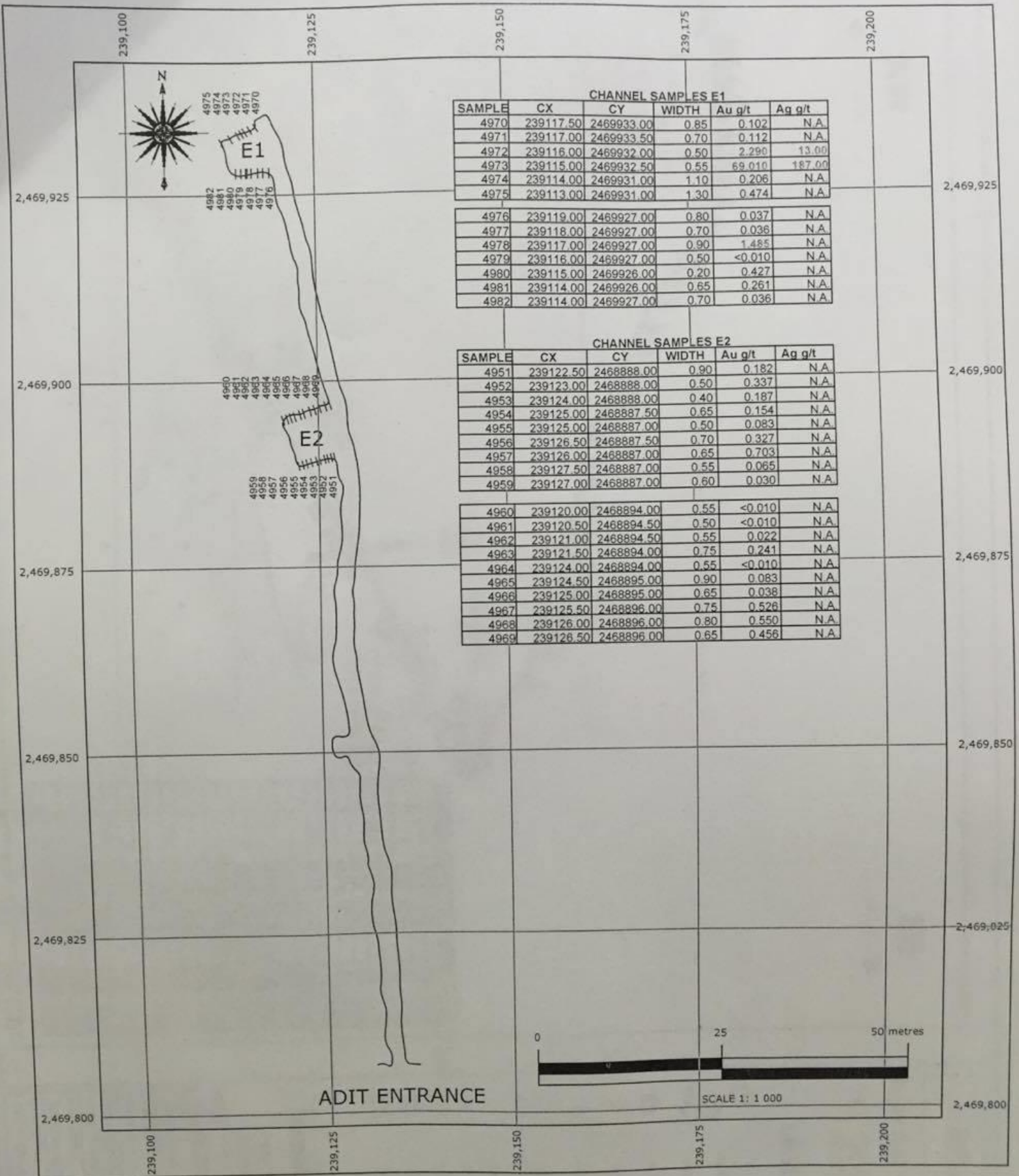


FIGURE 25. CHANNEL SAMPLES FROM THE UNDERGROUND DRILL-HOLE EXCAVATION PADS
